Sub: Consideration in terms of minutes of 6th meeting of the Empowered Committee constituted vide G.O. No. 139-F Dated: 19-08-2015, held on 31-03-2016 under the chairmanship of Commissioner/Secretary to Government Finance Department, for considering cases of eligible DRWs in terms of SRO 64 of 1994.

Whereas, the cases of various incumbents claimed to have been engaged before 31-01-1994 were submitted to Administrative Department for considering regularization of their service under SRO: 64 of 1994.

Whereas, the Administrative Department forwarded these cases to the competent authority (Finance Department) for considering them for regularization in terms of SRO 64 of 1994.


Whereas, the Empowered Committee constituted vide Government Order No. 139-F of 2015 Dated: 19-08-2015 discussed these cases in its 6th meeting held under the chairmanship of Commissioner / Secretary to Government, Finance Department held on 31-3-2016 and considered the cases for regularization case to case and the decision in respect of the following incumbents, besides others, have been conveyed vide letter No. FST/SF/16/2007, Dt: 07-06-2016 from Administrative Department, which are reproduced as under: -

Whereas the Empowered Committee has directed to the Department to issue consideration order in respect of the above mentioned incumbents as they are not found eligible for regularization in terms of SRO 64 of 1994.

Whereas the case of Shri Surat Singh (Sr. No. 01 above) has been considered separately and consideration order issued vide SF Order No. 163 of 2016 Dt: 10.06.2016 in pursuance of orders passed by the Hon'ble High Court J&K Jammu.

Now therefore, in view of the decision of the Empowered Committee the cases of the above incumbents have been considered and are rejected on the grounds metioned against each as they do not qualify for regularization in terms of SRO 64 of 1994.


