



TENDER NOTICE

Sealed tenders affixed with revenue stamp worth Rs. 2/- are hereby invited from the registered manufactures/suppliers for supply of 175 No's of Iron tree guards of size (1.5 ft x 1.5 ft x 5 ft) which shall be received in the Office of the under signed at Khanabal Anantnag on 14-01-2017 up to 01:00 pm. The tenders shall be opened on the same day at 2:00pm in the Divisional Office in presence of Tenderers who may like to be present, in case of any holiday the tenders will be opened on next working day.

Other terms and conditions shall follows as:-

1. The tenders should be accompanied by an earnest money of Rs. 5000/- (Rupees Five Thousand Only) in the shape of CDR pledged to Divisional Forest Officer, Social Forestry Division Anantnag.
2. The Tenderer should offer rate for tree guards with primer coated applied per Kg including carriage up to Divisional Head quarter Khanabal and shall mention the rates legible both in figures as well as in words. Moreover the Tenderer shall also enclose copies of income tax/sales tax clearance certificates besides registration of TIN in the sealed tender.
3. The successful Tenderer has to supply the required material strictly as per the specification within ten days from the date of issue of supply order. The successful Tenderer has also to execute an agreement before issuance of supply order.
4. The number of tree guards as reflected herein above may increase or decrease as per the requirement.
5. The payment of the supplied tree guards shall be subject to its qualitative test check/weightment in the field.
6. All the rates as applicable under various rules in vogue shall be borne by the successful Tenderer and therefore the rates offered by the intending Tenderers shall be inclusive of all taxes/encumbrances.
7. The undersigned reserves the right to accept or reject any Tender without assigning any reason thereof.
8. In case of any dispute the decision of Director, Department of Social Forestry J&K Shall be final and binding on the both parties.
9. Further details regarding the size, design, shape and specification of the tree guards can be had from the Office of the undersigned on any working day.
10. Any other condition that the department may deem necessary shall be announced before the due date and time for receipt of tenders.
11. The payment of the material shall be released in favour of the successful Tenderer only after completing/fulfilling all conditions as shall be laid down in the agreement and receipt of funds.
12. The successful tender has to deposit 10% of the total cost as security deposit in the shape of CDR pledged to DFO Social Forestry Division Anantnag before supply of the material.
