Sealed tenders affixed with revenue stamp worth Rs: 2/- are hereby invited from the registered manufactures/ suppliers for supply of 400 No. of Iron tree guards fabricated of size (1.5ftx1.5ft) with primer coated, which shall be received in the office of under signed at Baramulla on 27/01/2017 up to 3.00 PM. The tenders shall be opened on the same day at 04.00 PM in presence of tenderers who may like to be present.

Other terms and conditions shall be as follows:

- 01- The tenders should be accompanied by an earnest money of *Rs:20000/- (Rupees twenty thousand only)* in the shape of CDR pledged to Divisional Forest officer social Forestry Division Baramulla.
- 02- The Tenderer should offer rate for tree guards with primer coated applied , per KG including carriage up to Division office Baramulla and shall mention the rates both in figures as well as in words
- 03- Tax registration certificate with clearance certificate of latest quarter and Tin registration should be accompanied with the tender.
- 04- The successful Tenderer has to supply the required material strictly as per the specifications within (15) days from the date of issuance of supply order. The successful Tenderer has also to execute an agreement before the issuance of supply order.
- 05- The number of tree guards as reflected herein above may increase or decrease as per requirement.
- 06- The successful Tenderer has to deposit *10% of the total cost as security deposit in the shape of CDR pledged to DFO Social Forestry Division Baramulla* before supply the material.
- 07- The payment of the supplied tree guards shall be subject to its qualitative test check/weightment in the field.

- 08- All the taxes as applicable under various rules in vogue shall be borne by the successful Tenderer and therefore the rates offered by the intending Tenderers shall be inclusive of all taxes / encumbrances.
- 09- The under signed reserves the right to accept or reject any tender without assigning any reason thereof.
- 10- In case of any dispute the decision of Director Department of social forestry J&K shall be final and binding on both the parties.
- 11- Further details regarding the size, design , shape and specification of tree guards can be had from the office of the undersigned on any working day.
- 12- Any other condition which the department may deem necessary shall be announced before the due date and time.
- 13- The payment of material shall be released in favour of the successful Tenderer only after completing/ fulfilling all conditions as shall be laid down in the agreement and after receipt of funds.
